ELKHORN PUBLIC SCHOOLS MINUTES OF BOARD OF EDUCATION REGULAR MEETING AUGUST 12, 2024

The Regular Monthly Meeting of the Elkhorn Public Schools Board of Education was called to order at 6:30 PM. Members present: A. Parks, J. Shatel, R. Vokt, S. Ringenberg and M. Wortman. N. Rogic-Greufe was a few minutes late. President A. Parks noted that the meeting was governed by the Open Meetings Act, a copy of which is posted in the Board Room of the District Office. Advance notice of the Board meeting was published in the Omaha World Herald on August 5, 2024.

The meeting began with offering public comment. During the "Good News Report," S. It was moved by M. Wortman and seconded by J. Shatel to approve the Consent Agenda items including: approval of agenda, approval of minutes for the Monday, July 1, 2024 Regular Monthly Meeting and approval of August bills for payment.

It was moved by J. Shatel and seconded by S. Ringenberg to approve the release of contract of Debora Hossley for the 2024-25 school year effective immediately.

It was moved by S. Ringenberg and seconded by R. Vokt to approve the appointment of teachers Casey Riewaldt and Joan Wilson for the 2024-25 school year.

It was moved by J. Shatel and seconded by R. Vokt to approve the daily sub rate at \$170 per day with the long-term sub rate being \$190 per day for the 2024-25 school year. Notably, the daily sub rate will increase to the long-term sub rate after a substitute teacher reaches the 60th day of subbing as an incentive.

Shatel to approve updates to Policy 504.02 – Conduct and Discipline Code, Policy 1003 – Public Access to Records, Policy 204.12 – Public Participation at Board Meetings, Policy 706.01 – Purchasing Procedures, Policy 204.07 – Meeting Notice and Delivery of Materials, Policy 502.05 – Admission and Grade Placement, Policy 706.07 – Contracting Services, Policy 206.02 – Board Association Membership, Policy 503.02 – Attendance, Policy 409.01 – Certified Employee Professional Development, Policy 611.06 – Graduation Requirements, Policy 606.01 – Instructional Material Selection, Policy 802.04 – Meal Charge Policy, Policy 503.06 (New) – Preschool Enrollment. Also, move to rescind Policy 1007.03 – Loan of Textbooks to Private School Students given changes in legislation that shifts this to the Nebraska Department of Education.
