

**ELKHORN PUBLIC SCHOOLS
MINUTES OF BOARD OF EDUCATION
REGULAR MEETING
FEBRUARY 10, 2025**

The Regular Meeting of the Elkhorn Public Schools Board of Education was called to order at 6:30 PM. Members present: A. Parks, S. Ringenberg, N. Rogic-Greufe, J. Shatel, R. Vokt, and M. Wortman. President A. Parks noted that the meeting was governed by the Open Meetings Act, a copy of which is posted in the Board Room of the District Office. Advance notice of the Board meeting was published in the Omaha World Herald on February 3, 2025.

The meeting began with offering public comment. During the "Good News Report," N. Rogic-Greufe recognized ENHS Girls' Cross-Country coach Jordan Fuglestad was recently named the 2024 Girls' High School Cross-Country Coach of the Year by the U.S. Track & Field and Cross-Country Coaches Association.
